

Annual Personal Property Declaration to North Kingstown, RI as of 12/31/25 - EZ FORM

We have supplied this form for your convenience in the declaration of taxable personal property located in North Kingstown, Rhode Island.

The Law is Mandatory – A return must be filed and mailed to: Tax Assessor, 100 Fairway Drive, N Kingstown, RI 02852

Failure to file a return may result in an increased assessment and likely eliminates your right to appeal.

According to Rhode Island General Laws (§44-5-15 & 16), taxable property must be declared to the Assessor between **DECEMBER 31, 2025 and JANUARY 31, 2026**. If a taxpayer is unable to make such declaration within the prescribed time, they may submit written notice, prior to **JANUARY 31st**, of intention to submit declaration by **MARCH 15th**. Failure to file a true and exact account, within the prescribed time, likely eliminates the right to appeal. **§44-5-12.1 Assessment of tangible personal property.** "(a) All tangible personal property subject to taxation shall be assessed for taxation based on the original purchase price (new or used) including all costs such as freight and installation." Please refer to the statute referenced or call (401) 268-1531 for assistance with completing this form. No amended returns will be accepted after **MARCH 15th**.
